Dear Jeremy:

Thank you for the opportunity to provide comments on the City of Moses Lake Shoreline Master Program update. I am attaching a table that includes the Department of Natural Resources (DNR) specific comments. The Department of Natural Resources is pleased to see that the City of Moses Lake has proposed a shoreline master program Aquatic shoreline environmental designation that covers areas waterward of the ordinary high water mark (OHWM). As you know, these areas are generally managed by DNR, and as managers and stewards of these lands, the Department seeks to maintain a balance of benefits provided by state-owned aquatic lands for the benefit of the citizens of the state of Washington. These benefits include: encouraging direct public use and access; fostering water-dependent uses; ensuring environmental protection; and utilizing renewable resources. The Department would like to congratulate the City of Moses Lake for updating its Shoreline Master Program. DNR's comments are offered from the perspective of a land manager rather than a regulator. The Department is always looking for opportunities to plan and coordinate with local governments engaged in updating shoreline master programs and our hope is that these comments are helpful.
