

1 the obligations of the District hereunder shall be responsible
2 solely to the District.

3 3. LIBRARY HOURS. Regular hours of service will be
4 established by the District. In so doing, the District shall take
5 into account the population served, the use made of the library
6 service and the funds available in the District's budget.

7 4. BOOKS AND OTHER MATERIALS. The District will provide
8 books and other library materials based on population served, space
9 available, the use made of materials and the funds available in the
10 District's budget. The District shall have the sole responsibility
11 for the selection and maintenance of such materials.

12 5. LIBRARY QUARTERS. The Municipality, at its sole
13 expense, shall provide a suitable building or space in a building
14 for library quarters and will pay all necessary maintenance and
15 utilities relating to such library quarters. The specific provision
16 for providing library quarters shall be as provided in that certain
17 companion agreement entitled "Library Building and Maintenance Agree-
18 ment".

19 6. DISTRICT FEE. The Municipality, in consideration of
20 the library services to be rendered hereunder, shall pay the District
21 in the year 1983, and in each year thereafter during the term of
22 this Agreement, a sum of money equal to the District's prevailing
23 levy rate in each contract year multiplied by the final assessed
24 valuation in each contract year for property within the corporate
25 limits of the Municipality. Payment shall be made in four (4) equal
26 installments to be paid to the District on or before March 1, June
27 1, September 1 and December 1 of each year. The District shall
28 notify the Municipality within ten (10) days after it shall adopt a
29 levy rate for the following year.

30 7. TERM. This Agreement shall be effective as of
31 January 1, 1983, and shall remain continuously in effect unless
