
### GRANT COUNTY FIRE DISTRICT # 8 AND CITY OF MOSES LAKE SERVICE AGREEMENT


This Agreement between Grant County Fire District # 8, (hereinafter referred to as "Customer") and the City of Moses Lake, (hereinafter referred to as ("Provider")), in accordance with the following terms, is entered into this 10<sup>th</sup> day of April 2002, by and between Grant County Fire District # 8 and the City of Moses Lake a municipality organized and existing under the laws of the State of Washington.

- 1) Provider agrees to provide to the Customer paramedic rendezvous services utilizing licensed vehicles, personnel, and equipment in compliance with the laws of the State of Washington.
- 2) Provider agrees to maintain general liability insurance in the amount of \$1,000,000 to protect against an incident arising out of or in connection with the services provided by the Provider. Provider agrees to maintain Worker's Compensation coverage for all Providers' employees.
- 3) Provider hereby indemnifies and holds Customer harmless from any and all liability, losses, damages, claims, or causes of action including any expense which may arise out of performance provided by Provider or its' employees.
- 4) Customer hereby indemnifies and holds Provider harmless from any and all liability, losses, damages, claims, or causes of action including any expense which may arise out of performance provided by Customer or its' employees.
- 5) Provider shall perform all services for Customer as an independent contractor.
- 6) This agreement will apply to ALS rendezvous services provided by the provider at the request of the Customer.
- 7) The Provider will bill the Customer \$100 for each time that the Provider is requested and provides ALS rendezvous services. The Provider will bill the Customer on a monthly basis.
- 8) The Customer agrees to use Provider as the preferred responder and first call on all ALS rendezvous occurring while en route to the Moses Lake area.
- 9) The Provider agrees to make available to the Customer all records as available and legal to assist in billing and collection procedures.
- 10) This service agreement contains the entire agreement of the parties hereto.

- 11) The terms of this agreement will commence on this 10<sup>th</sup> day of April, 2002. This contract will renew automatically each year.
- 12) Each of the undersigned individuals represents and warrants that they are duly authorized to execute this agreement on behalf of the party indicated below and this agreement is binding upon said party in accordance with its terms.

IN WITNESS WHEREOF, the City of Moses Lake and Grant County Fire District # 8 have duly executed this agreement effective the date above.
